Refunds: Scratches received prior to the closing date will be refunded, less \$25 office fee. No refunds after the closing date. If for any reason the show if canceled – partial credit applied. After closing date, refund minus \$25 office fee, only if same spot can be filled from wait list (if there is a wait list).

Late Fees: Entries received after the closing date will be subject to a \$25 late fee for the Horse Trials, \$15 late fee for the Combined Tests and a \$10 late fee for the Dressage Test of Choice and Stadium Round.

Dressage and Stadium Jumping will be on the Attwood Equestrian Surfaces Footing.

Show office opens one hour before the first ride and closes one hour after the last ride.

Ride Times will be available at www.StableViewFarm.com Thursday prior to the event.

Riders may wear cross-country attire and gear for show jumping.

Medical armbands, safety vest and ASTM approved helmets are required. Braiding optional.

Pinny holders, medical armbands available for purchase at the show office.

All dogs must be leashed.

Food on grounds.

Levels may be divided/combined if entries warrant.

The competition will be held in accordance with current USEA and USEF rules.

Valid negative Coggins within last 12 months required.

Awards:

Ribbons awarded 1st through 6th place.

FITS \$100 Gift Certificates given to the winner of each division of the horse trials only at each event.

TIP Awards and Prizes for the highest placed Thoroughbred Horse at each level.

The 2020 Eventing Academy Series will be from December 2019 through November 2020. Year-end prizes will be awarded at the December 2020 Eventing Academy Awards Ceremony. Competitors placing 1^{st} through 6^{th} in their class will be awarded points as follows: 1^{st} place -7 points, 2^{nd} place -5 points, 3^{rd} place -4 points, 4^{th} place -3 points, 5^{th} place -2 points, and 6^{th} place -1 point.

Year-End Awards: Horse and Rider combination with the most accumulated points at each level will receive year-end prizes. In addition, the horse and rider combination who has won the most points overall will be presented a grand prize. Ties will be broken by lowest average score.

NEW for 2020: Trainer Incentive Award: The trainer who brings the most students to any Eventing Academy Schooling Day or Horse Trial will be eligible for year-end awards. Students must list their trainer on their forms. Each student will count as one point (one point for schooling day and one point for horse trial). At the end of the series, the trainers with the top three attendance scores will receive a prize.

WEREAS, IN CONSIDERATION FOR AND AS AN INDUCEMENT FOR SAGE MILL, LLC, CYNTHIA A. OLLIFF, BARRY M. OLLIFF AND STABLE VIEW, LLC AGREEING TO ALLOW THE UNDERSIGNED TO ENGAGE IN EQUINE ACTIVITIES (INCLUDING BUT NOT LIMITED TO RIDING, TRAINING, BOARDING AND/OR CARING FOR HORSES OWNED, LEASED OR UNDER THE CONTROL OF THE UNDERSIGNED (THE "HORSES") AT THE FACILITY OF THE AFORESAID LOCATED ON SPRINGFIELD CHURCH ROAD (THE "EQUESTRIAN CENTER") AND ADJACENT PROPERTY UPON WHICH CERTAIN RIDING TRAILS ARE LOCATED (THE "RIDING ACCESS PROPERTY") (TOGETHER THE EQUESTRIAN CENTER AND THE RIDING ACCESS PROPERTY SHALL BE REFERRED TO AS THE "FARM"), ALL IN AIKEN COUNTY, SOUTH CAROLINA, THE UNDERSIGNED HEREBY AGREES AS FOLLOWS:

- 1. I (WE) AGREE TO HOLD SAGE MILL, LLC, ITS SUCCESSORS AND ASSIGNS, (THE "COMPANY") CYNTHIA A. OLLIFF AND BARRY M. OLLIFF (COLLECTIVELY, THE "OLLIFFS"), AND STABLE VIEW, LLC ("SV"), THEIR MEMBERS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND EMPLOYEES HARMLESS FROM ANY CLAIM FOR LOSS OR INJURY THAT MAY BE ALLEGED TO HAVE BEEN CAUSED DIRECTLY OR INDIRECTLY TO ANY PERSON OR THING (INCLUDING THE HORSES) BY THE ACT OF OTHER PERSONS, OWNERS, GUARDIANS AND/OR THEIR ANIMALS WHILE AT THE FARM.
- 2. I (WE) ACKNOWLEDGE AND AGREE THAT THE COMPANY, SV AND THE OLLIFFS SHALL NOT BE LIABLE FOR ANY SICKNESS, DISEASE, THEFT, DEATH OR INJURY WHICH MAY BE SUFFERED BY THE HORSE(S) WHILE AT THE FARM. I (WE) UNDERSTAND AND ACKNOWLEDGE THAT ALL RISKS RELATED TO BOARDING, TRAINING, RIDING AND SHIPPING OF HORSE(S), OR FOR ANY OTHER REASON, ARE TO BE BORNE BY US. I (WE) FURTHER AGREE TO HOLD COMPANY, SV AND THE OLLIFFS HARMLESS FROM ANY CLAIM FOR LOSS TO OUR HORSE(S) BY DISAPPEARANCE, THEFT, DEATH OR OTHERWISE, AND FROM ANY CLAIM FOR DAMAGE OR INJURY TO OUR HORSE(S), WHETHER SUCH LOSS, DISAPPEARANCE, THEFT, DAMAGE OR INJURY, BE CAUSED OR ALLEGED TO BE CAUSED BY THE NEGLIGENCE OF COMPANY, SC OR THE OLLIFFS, OR BY THE NEGLIGENCE OF ANY OTHER PERSON, OR ANY OTHER CAUSE OR CAUSES. THIS WAIVER RELATES SPECIFICALLY TO STABLE VIEW LLC. RIDING ON ADJACENT PROPERTY INVOLVES RISKS FOR WHICH STABLE VIEW LLC CANNOT BE HELD RESPONSIBLE.

CODE ANNOTATED SECTION 47-9-720, AN EQUINE ACTIVITY SPONSOR OR AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT RESULTING FROM THE INHERENT RISK OF EQUINE ACTIVITY, AND NO PARTICIPANT OR PARTICIPANT'S REPRESENTATIVE MAY MAKE A CLAIM AGAINST, MAINTAIN AN ACTION AGAINST, OR RECOVER FROM AN EQUINE ACTIVITY SPONSOR, OR AN EQUINE PROFESSIONAL FOR INJURY, LOSS, DAMAGE, OR DEATH OF THE PARTICIPANT RESULTING FROM AN INHERENT RISK OF EQUINE ACTIVITY.

I (WE) UNDERSTAND THAT WE ARE WAIVING THE RIGHT TO BRING A LAWSUIT OR MAKE ANY OTHER CLAIM AGAINST COMPANY, SV OR THE OLLIFFS, THEIR MEMBERS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND EMPLOYEES, AND I FURTHER UNDERSTAND THAT THIS RELEASE AND INDEMNITY WILL BE PRESENTED AS A COMPLETE DEFENSE AGAINST ME IF I (WE) DO BRING ANY LAWSUIT OR CLAIM AGAINST COMPANY, SV OR THE OLLIFFS, THEIR MEMBERS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND/OR EMPLOYEES.
