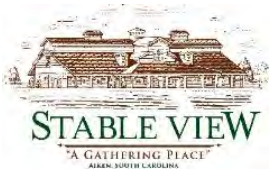

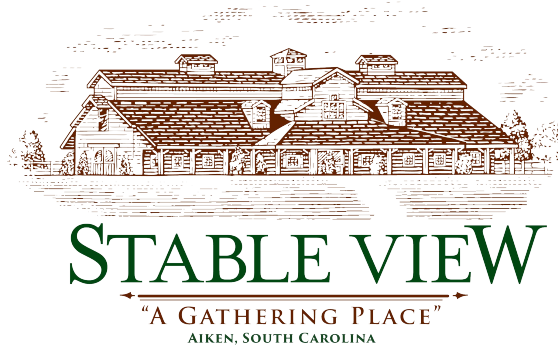

HUNTER PACE/TRAIL RIDE RULES AND REGULATIONS

Speeds used to calculate the Optimum Time:

First Flight: 250mpm - 10:30 AM

Hilltopper: 200mpm - 12:00 PM

Tailgater: 150mpm - 1:30 PM

Rules:

1. Jumping teams must jump or attempt to jump all the fences.
2. Flat only teams should pass closely to the jumps.
3. All team members must finish the course to be considered for the final placing.
4. The last team member to cross the finish line is the team's time. If you are the last member of your team, please let the finish timer know you are.
5. All riders must wear boots and ASTM approved hard hats.

Reminders:

1. **Enter through Gate 4 (Gate closest to Boyd Martin ETB Schooling field)**
2. Check in 30 minutes or earlier than your ride time.
3. Warm-up will be in the Eventing Academy field.
4. Please be prepared to start before or at your scheduled time.
5. When passing teams, please do so no faster than a trot and only where safe.
6. Non-jumping teams may jump any jumps on the paths.
7. Start and Finish share the same line. Please use caution and a safe pace.

___ 1. I (WE) AGREE TO HOLD SAGE MILL, LLC, ITS SUCCESSORS AND ASSIGNS, (THE "COMPANY") CYNTHIA A. OLLIFF AND BARRY M. OLLIFF (COLLECTIVELY. THE "OLLIFFS"), AND STABLE VIEW, LLC ("SV"), THEIR MEMBERS, DIRECTORS, OFFICERS, AGENTS, VOLUNTEERS AND EMPLOYEES HARMLESS FROM ANY CLAIM FOR LOSS OR INJURY THAT MAY BE ALLEGED TO HAVE BEEN CAUSED DIRECTLY OR INDIRECTLY TO ANY PERSON OR THING (INCLUDING THE HORSES) BY THE ACT OF OTHER PERSONS, OWNERS, GUARDIANS AND/OR THEIR ANIMALS WHILE AT THE FARM.
