Sunday – One-day schooling horse trial, combined test, dressage test of choice, or stadium round.

Dressage and Stadium Jumping will be on Attwood Equestrian Surfaces Footing.

Ride Times and Stabling Chart will be available on the Stable View Website and Event Entries.

Riders may wear cross-country attire for show jumping.

Medical armbands required for under-lying conditions. Safety vest and ASTM approved helmets are required. Braiding optional.

All dogs must be leashed.

Food on grounds if COVID-19/USEF restrictions will allow. Levels may be divided/combined depending on entries.

Eventing Academy's will be held in accordance with current USEA and USEF rules.

Valid negative Coggins within last 12 months is required.

AWARDS

Ribbons awarded 1st through 6th place. Ribbons and Testa will not be mailed.

TIP Awards and Prizes for the first and second highest placing Thoroughbred Horse at each level.

The 2023 Eventing Academy Series will be from December 2022 through November 2023. Year-end prizes will be awarded at the December 2023 Eventing Academy Awards Ceremony. Competitors placing 1st through 6th in their class will be awarded points as follows: 1st place – 7 points, 2nd place – 5 points, 3rd place – 4 points, 4th place – 3 points, 5th place – 2 points, 6th place – 1 point, and attendance -1 point. Year end winners should collect Prizes from the Stable View Office by December 31st, 2023.

Year-End Awards: The Horse and Rider combination with the most accumulated points at each level will receive a year-end prize. The horse and rider combination winning the most overall points will be presented with prizes to a value in excess of \$1,000. Ties will be broken by the lowest average score. The total value of prizes to be distributed is estimated to be in excess of \$20,000.

Trainer Incentive Award: The trainer who brings the most students to the Eventing Academy Sunday Schooling Show(s) will be eligible for year-end awards. Students must list their trainer on their entry forms. Each student will count as one point. 1st - \$500 cash, 2nd - \$300 cash & 3rd - \$200 cash. Ties will be broken by the lowest score a the trainer had in the 2023 season.

WEREAS, IN CONSIDERATION FOR AND AS AN INDUCEMENT FOR CYNTHIA A. OLLIFF, BARRY M. OLLIFF AND STABLE VIEW, LLC AGREEING TO ALLOW THE UNDERSIGNED TO ENGAGE IN EQUINE ACTIVITIES (INCLUDING BUT NOT LIMITED TO RIDING, TRAINING, BOARDING AND/OR CARING FOR HORSES OWNED, LEASED OR UNDER THE CONTROL OF THE UNDERSIGNED (THE "HORSES") AT THE FACILITY OF THE AFORESAID LOCATED ON SPRINGFIELD CHURCH ROAD (THE EQUESTRIAN CENTER"), ALL IN AIKEN COUNTY. SOUTH CAROLINA, THE UNDERSIGNED HEREBY AGREES AS FOLLOWS:

2. I (WE) ACKNOWLEDGE AND AGREE THAT THE COMPANY. SV AND THE OLLIFFS SHALL NOT BE LIABLE FOR ANY SICKNESS, DISEASE, THEFT, DEATH OR INJURY WHICH MAY BE SUFFERED BY THE HORSE(S) WHILE AT THE FARM. I (WE) UNDERSTAND AND ACKNOWLEDGE THAT ALL RISKS RELATED TO BOARDING, TRAINING, RIDING AND SHIPPING OF HORSE(S), OR FOR ANY OTHER REASON, ARE TO BE BORNE BY US. I (WE) FURTHER AGREE TO HOLD COMPANY, SV AND THE OLLIFFS HARMLESS FROM ANY CLAIM FOR LOSS TO OUR HORSE(S) BY DISAPPEARANCE, THEFT, DEATH OR OTHERWISE, AND FROM ANY CLAIM FOR DAMAGE OR INJURY TO OUR HORSE(S), WHETHER SUCH LOSS, DISAPPEARANCE, THEFT, DAMAGE OR INJURY, BE CAUSED OR ALLEGED TO BE CAUSED BY THE NEGLIGENCE OF COMPANY, SC OR THE OLLIFFS, OR BY THE NEGLIGENCE OF ANY OTHER PERSON, OR ANY OTHER CAUSE OR CAUSES.
